FREQUENTLY ASKED QUESTIONS

VILLAGE OPEN HOUSE MEETING – CONSTRUCTION STAGE

Downtown Streetscape Improvements – South Half (61F71)

Section No. 18-00099-00-LS

Village of Bensenville/DuPage County

1. What is the goal for the project?

- The goal is to extend the recently constructed streetscape that was installed north of Metra Railroad and along Railroad Ave. The narrowed roadways will improve on the pedestrian and non-motorized access to the Downtown area and Metra Station. Roadway beautification creates a sense of place, stimulates growth, and fosters community support. The project works to remove barriers to pedestrians and non-motorized vehicles and increases the ability for residents to walk and bike to the downtown area. The project creates enhanced opportunities for community and economic development of the Downtown area. Benefits include crosswalk improvements, sidewalk replacements to accommodate ADA accessibility, street amenities such as bicycle facilities, benches, landscaping, public spaces, etc.

2. How will my property be affected by the improvement?

- No additional right of way (a.k.a. land acquisition) is required; in part since the proposed roadway is not being widening and will be reconstructed within the existing public right of way. The wider sidewalk and streetscape elements will enhance the properties.

3. How will my property be affected during construction?

- The major sections of this project will be constructed under staged construction which will include temporary changes to the existing traffic patterns. One-way traffic will be provided during construction. For the safety of the general motoring public, patrons, and construction workers, on-street parking during the project will not be permitted. On street parking is available along Main St, Center St and Addison St on the north side of the tracks. Additionally, on street parking is also available along Railroad Ave between Center St and York Rd.

4. How are the improvements funded?

- The project construction cost is approximately \$2,800,000.00. The Village of Bensenville has received \$1,045,800.00 in Federal Funds through the Illinois Transportation Enhancement Program.

5. When will the construction start and end?

- The start of construction is anticipated to begin after the Independence Day. It will be completed by the end of November 2019 with punch list items likely to be completed in Spring of 2020.
