I am pleased to help you with your July 11, 2019 Freedom of Information Act ("FOIA"). The Village of Bensenville received your request on July 11, 2019. You requested copies of the items indicated below:

"Please provide our office with copies of all outstanding violations and balances for fees, etc. on the property known as: 1107 Stoneham Street, Bensenville, Illinois 60106."

After a search of Village files, the following information was found responsive to your request:

- 1) Village of Bensenville Current Water Bill for 1107 Stoneham Street as of July 11, 2019. (1 pg.)
- 2) DuPage County Statement of Lien Claim No R2019-050561 for 1107 Stoneham Street. (1 pg.)

Please be aware that on February 25, 2014 the Village Board adopted Ordinance No. 16-2014 that requires a Real Estate Transfer Inspection (RETI) be conducted prior to most property sales within Bensenville. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of the FOIA, 5 ILCS 140/11.
