- 1) Village of Bensenville Permit Application No. 9393. (2 pgs.)


These are all of the documents that can be discovered responsive to your request.

Consequently, certain unique identifiers have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and made the foregoing determination to deny a portion of your FOIA Request as indicated. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.
