An Ordinance Amending Ordinance No. 30-2014, Adopted June 24, 2014 Amending the Municipal Water/Sewer Rates of the Village of Bensenville to Correct a Scrivener's Error. (Consent Agenda)

Motion: Trustee Janowiak made a motion to approve the Consent Agenda as presented. Trustee Ridder seconded the motion.

**PRESIDENT'S
REMARKS:**

Assistant Village Manager, Dan Di Santo, stated at the May 20, 2014 Public Safety Meeting the Committee directed staff and the Village Attorney to draft public referenda questions related to O'Hare impacts. Mr. Di Santo stated the deadline to place a question on the November 4, 2014 ballot is August 18, 2014 and a municipality may approve up to three questions. Mr. Di Santo stated staff presents four questions for the Board to consider related to (1) requiring the City of Chicago to prepare a new noise compatibility plan for O'Hare, (2) making fly-quiet restrictions mandatory, (3) requiring the federal government to revisit the criteria they use to establish noise and air pollution standards, and (4) enacting statewide legislation establishing a Community Noise Equivalent Metric. Mr. Di Santo stated in order to place these questions on the ballot, the Village Board should pass up to three separate Resolutions. Mr. Di Santo stated Village Staff suggests the passage of options 1, 2 and 3.
