Single Family

John Wassinger, Bensenville Park District President, was present and sworn in by Chairman Markowski. The Bensenville Park District is requesting the four (4) subdivided lots be rezoned from Low Density Single-Family Residential District (RS-1) back to their previous High Density Single-Family Residential District (RS-5). The Village altered the zoning of the site from high density single family to low density single family with the adoption of the

1993 Zoning Map.

Although the RS-1 classification is congruent with the Village's adjacent property (Redmond Recreational Complex), the four (4) subdivided lots in question are also similar to the abutting properties to the west, which are zoned RS-5. If approved, the request for the rezoning will allow the Bensenville Park District to sell the vacant lots as four homesites rather than one. Public Works Staff is concerned with the floodplain elevation due to the fact that the property is prone to flooding during major storms. Commissioner Moruzzi raised concern regarding the floodplain. Mr. Wassinger stated that any potential buyer of the property will have full disclosure before purchase.

Mr. Keane stated that he does not believe the property can be sold as high density single family lot. Mr. Keane expressed his concerns with building property on a floodplain.

Mr. Wassinger stated that there was no immediate plans for the property and would like to have options for any potential buyer.

Community and Economic Director, Scott Viger, stated that before anything is constructed on the property, the engineering and flood issues as well as the rezoning all need to be resolved. The question is which one happens first. Staff believes accomplishing the rezoning fist is appropriate.
