Request: Conditional Use Permit Outdoor Storage & Variance

Brian D. Milberg, Matthew J. Stauber, and Timothy Kelly were all present and sworn in by Chairman Markowski. KTR Capital Partners has thirty six locations around O'Hare. This is their first time dealing with the Village of Bensenville. The proposed tenant will be PODs. The pods will be stacked in front of the loading dock doors. Two pods will be stacked on top of one another. The pods will be empty when they are stored outside. 120-150 pods will be stored outside. Pods that are full along with company trucks will be stored inside. Bensenville Fire Protection District #2 Chief

has no objections of PODs moving in to this location. All

maintenance issues are up to code. Commissioners are requesting that striping is done that pods will be kept in. Staff recommends

approval.

Public Comment - Paul Lambardo - 1121 N. Ellis

Mr. Lambardo is a business owner in town. He has concerns with the outdoor storage of the pods. If something is accidently left in the pod and a fire is started. Mr. Lambardo would like to see the pods stored inside. Mr. Lambardo has a conditional use permit to allow outside storage of trucks and trailers at his property but feels pods without wheels is different.

Motion: Commissioner Moruzzi made a motion to approve a conditional

use permit for outdoor storage and a variance with the three conditions enumerated with the staff report and the addition of striping the parking lot. Commissioner Ventura seconded the

motion.
