I am pleased to help you with your March 15, 2018 Freedom of Information Act ("FOIA"). The Village of Bensenville received your request on March 15, 2018. You requested copies of the items indicated below:

"Lien information, including release for the attached lien recording under Document #R8001-223127, regarding the property at 414 Marion Street, Bensenville, IL 60106, PIN 03-24-107-013."

After a search of Village files, the following information was found responsive to your request:

- 1) Village of Bensenville Current Water Bill for 414 Marion Street as of March 15, 2018. (1 pg.)

Please be aware that on February 25, 2014 the Village Board adopted Ordinance No. 16-2014 that requires a Real Estate Transfer Inspection (RETI) be conducted prior to most property sales within Bensenville. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of the FOIA, 5 ILCS 140/11.
