Re: April 23, 2018 FOIA Request

Dear Mr. Meadows:

I am pleased to help you with your April 23, 2018 Freedom of Information Act ("FOIA"). The Village of Bensenville received your request on April 24 2018. You requested copies of the items indicated below:

"Pursuant to FOIA and as a member of the media, I hereby request, in machine readable CSV or XLS formats to the extent practicable, the following public records:

Records sufficient to show the following information for every instance of a citation issued since July 30, 2016 for violations of 720 ILCS 550/4(a) or 720 ILCS 600/3.5 or equivalent offenses (i.e. local ordinance or civil law citations for violations of the Cannabis Control Act for possession of cannabis, marijuana-related drug paraphernalia):

*the citation **number**, the **time**, **date**, **location** of offense, and the **race/age/sex/ZIP** code of residence of each cited offender."*

After review of Village records, you agreed to narrow your request via email dated April 24, 2018 to request the following information:

"Assuming those 87 arrests were sent to the county, you don't need to include them.

Anything that resulted in a misdemeanor/felony prosecution you can exclude.

I'm just looking for the (data from) civil and ordinance citations.

Is that more manageable?"

After a search of Village files, the Village has produced the enclosed spreadsheet responsive to your request.


These are all of the documents that can be discovered responsive to your request.

Please be aware that per State Law, several records have been expunged. Here is the section of the law:

Commencing 180 days after July 29, 2016 (the effective date of Public Act 99-697), the law enforcement agency issuing the citation shall automatically expunge, on or before January 1 and July 1 of each year, the law enforcement records of a person found to have committed a civil law violation of subsection (a) of Section 4 of the Cannabis Control Act or subsection (c) of Section 3.5 of the Drug Paraphernalia Control Act in the law enforcement agency's possession or control and which contains the final satisfactory disposition which pertain to the person issued a citation for that offense.
