FREEDOM OF INFORMATION ACT REQUEST

Definitions:

For the purpose of this request for records pursuant to the Illinois Freedom of Information Act, 5 ILCS 140/1 et seq. ("FOIA"), the following terms have the following meanings:

"**Love's**" means Loves's Travel Stops & Country Stores, its affiliates, employees, agents, representatives, associates, or joint venturers.

"**Representatives of Love's**" means all owners, officers, directors, employees, agents, consultants, developers, contractors, real estate brokers, architects, attorneys, and persons acting on behalf or at the direction of Love's.

"**Bruner**" means Chad Bruner of Love's.

"**Bensenville**" means the Village of Bensenville, Illinois.

"**Representatives of Bensenville**" means all Bensenville elected and appointed officials, employees, agents, consultants, attorneys, and representatives.

"**Public Records**" has the meaning ascribed in 5 ILCS 140/2.

"**Communications**" has the meaning ascribed below.

FOIA Request:

You are hereby requested to produce copies of the following Public Records pursuant to FOIA:

1. All Public Records related to any correspondence, letters, emails, texts, social media and other communications of any type whatsoever, and any memoranda, minutes, notes, records and other documents of any meetings, telephone conferences, or other verbal communications (all of the forgoing, collectively, "**Communications**"):

a. by Love's, Representatives of Love's or Bruner to any Representatives of Bensenville from January 1, 2017 to the present;

b. by any Representatives of Bensenville to Love's, Representatives of Love's, or Bruner from January 1, 2017 to the present;

c. between or among Love's, Representatives of Love's, Bruner and/or any Representatives of Bensenville regarding a Love's store within in Bensenville, including at 1101-1171 Tower Lane, Bensenville; and

d. any Communications which include reference to Love's, Representatives of Love's, Bruner or a Love's store within Bensenville, including at 1101-1171 Tower Lane,

Bensenville, even if not falling within any of the requests in subparagraphs 1(a), (b) and (c).

2. All Public Records related to any drawings, plans, prints, specifications, proposals, reports, studies, and tests, of any type whatsoever, of or regarding a Love's store in Bensenville, including at 1101-1171 Tower Lane, Bensenville.
