BACKGROUND:

The Village of Bensenville owns and operates the 1.8 million gallon underground reservoir as well as 500,000-gallon water tower along Church Rd, which is a key facility for the intake and distribution of domestic water throughout the Village. The mechanical/electrical/plumbing equipment to operate this tank is housed inside a building adjacent to the tank. This is original equipment was installed in the year 1959. Since then, make shift minor improvements have been made to the station as technology and industry has evolved but the existing infrastructure is obsolete. The station requires more permanent upgrades to effectively operate the facility which will continue to serve the Village for years to come.

KEY ISSUES:

This project was advertised for bids on October 31, 2019. Bids were received on November 21, 2019 for the project. Three (3) contractors submitted bids. Dahme Mechanical submitted the most responsible and responsive bid. A summary of the results is included below.

Dahme Mechanical Industries, Inc (DMI)	\$595,000.00	1
AMS Mechanical Systems, Inc	\$595,000.00	2
Independent Mechanical Industries, Inc	\$602,460.00	3
Engineer's Estimate	\$671,875.00	N/A

As shown in the table above, both DMI and AMS submitted a bid in the exact same amount. After consulting the village attorney, the staff performed a financial check on both contractors. Based on the review of financials, both contractors can perform the scope of improvements. Furthermore, staff also requested a list of references for similar type of municipal projects from both contractors. Staff contacted three references for each contractor. Based on the feedback provided by the references, staff has determined DMI to be the most responsible and responsive contractor for this project.

RECOMMENDATION:

Staff recommends award of the contract to Dahme Mechanical Industries, Inc in the Amount of \$595,000.

BUDGET IMPACT:

This project will be under construction in 2020. In FY2020, staff has budgeted \$677,000 for the improvements at this facility.
