ORDINANCE # 17-2001

**AUTHORIZING A CONDITIONAL USE
MIXING, COMPOUNDING AND PACKAGING
OF SOAP, WASHING OR CLEANING
50 FRONTIER WAY**

BE IT ORDAINED by the President and Board of Trustees of the Village of Bensenville, Counties of DuPage and Cook, Illinois, as follows:

SECTION ONE: There is hereby granted a conditional use to allow for the blending of detergents ("Mixing, Compounding And Packaging Of Soap, Washing Or Cleaning") at 50 Frontier Way, with the following conditions:


1. That the Fire Department's remaining requirements for work to be completed at 50 Frontier Way will be met as guaranteed in the attached letter from Chemstation dated February 13, 2001.
2. That the Fire Department's requirements for work to be completed at 100 Frontier Way will be met as guaranteed in the attached letter from Alliance Refrigeration dated February 15, 2001.

SECTION TWO: All ordinances in conflict herewith are repealed to the extent of said conflict.

This ordinance is in full force and effect from and after passage and publication according to law.



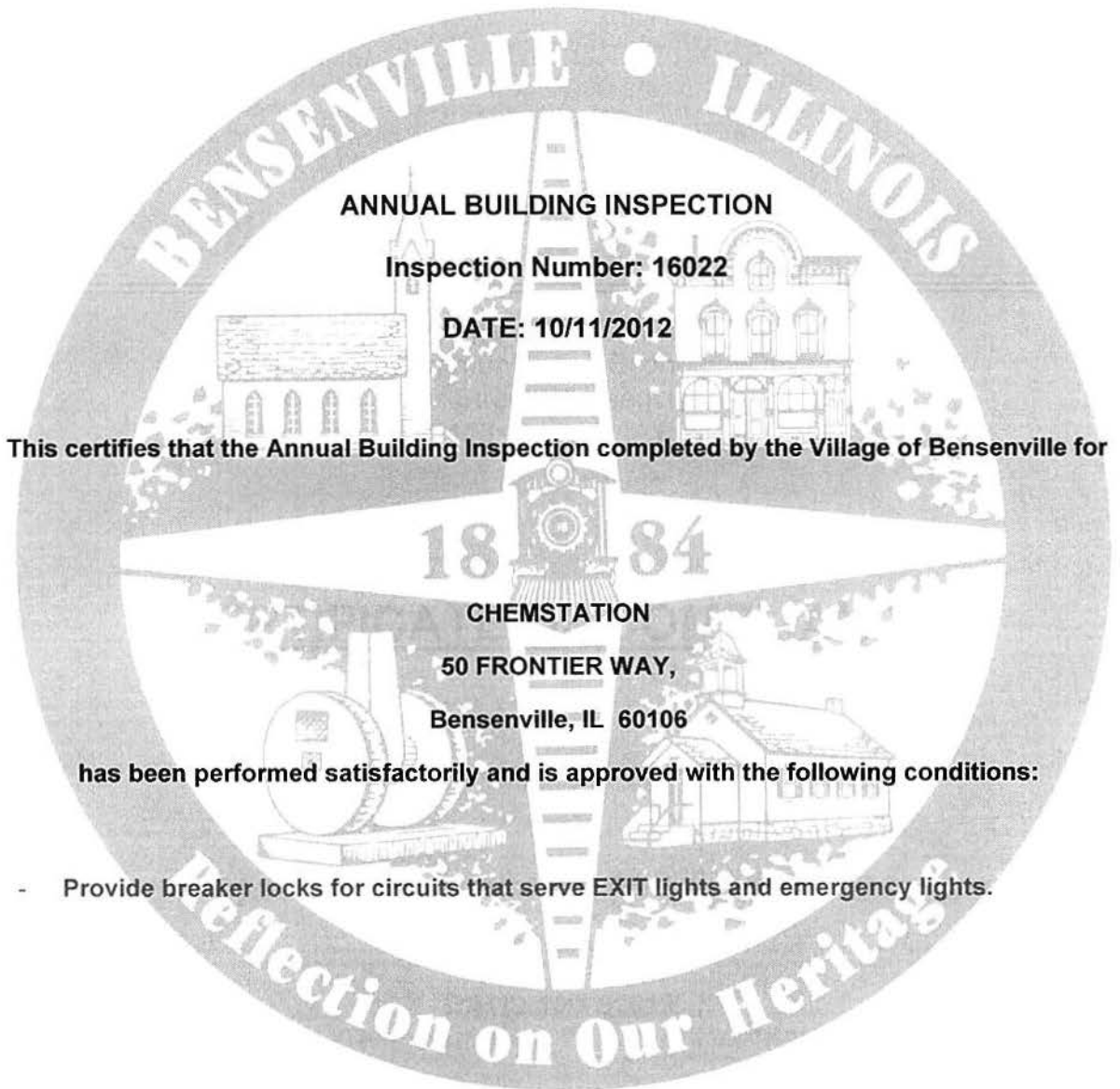
