Dear Ms. Genova:

I am pleased to help you with your December 22, 2022 Freedom of Information Act ("FOIA"). The Village of Bensenville received your request on December 22, 2022. You requested copies of the items indicated below:

"I'm reaching out on behalf of the Democratic Party of Illinois. We are requesting the 1) full names of the candidates who have filed petitions with your offices up to this point, 2) the offices those candidates are running for whether that be library board, park district, etc 3) and addresses associated with their candidacy from each of the municipal entities in DuPage County. The Clerk's office has provided this info for school board candidates on their website, but we are in the process of compiling this information, in addition to the school board candidates, for our internal records (non-commercial)."

After a search of Village files, the following information was found responsive to your request:

- 1) Page One of the "Moving Bensenville Forward" Party Petitions. (1 pg.)
- 2) Page One of the "The Citizens Initiative Party" Party Petitions. (1 pg.)


These are all the records found responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclose. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords, or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain identifiers have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of the FOIA, 5 ILCS 140/11.
